OBEDIENCE PRE - ENTRIES: \$7.00 for 1st entry of a dog each day & \$4.00 each additional entry of same dog on same day. Pre-entries close Saturday, February 16th, 2019.

OBEDIENCE DAY- OF - MATCH ENTRIES: Day-of-match entries will be accepted from 8:30 am until Noon each day. Pre-entered dogs will run first. Day-of-Entry Fee is \$10.00 for the 1st entry of each dog each day. Each additional entry of the same dog on same day is \$5.00.

OBEDIENCE CLASSES OFFERED: The use of training aids (prong collars, toys, food) will be allowed. Each ring will have a mentor who will call the pattern (AKC or UKC). Maximum of 7 minutes for all obedience runs with the exception of 10 minutes for utility.

Ring 1: Beginner Novice, Preferred Novice (AKC), Novice (AKC or UKC) & Sub Novice (UKC)

Ring 2: Open & Grad Novice (AKC or UKC), Preferred Open (AKC)

Ring 3: Utility & Grad Open (AKC or UKC), Preferred Utility (AKC)

RALLY & AGILITY RUN THRU: No pre-entry. Pay at registration table from 8:30 am until 2:00 pm. **Entry Fees:** \$5.00 for 1st run of a dog; \$3.00 for 2nd run of the same dog. **Runs will not be scored. 3 minutes per run.**

Rally Courses: Runs will begin at 9:30 am both days. Rally Course will be a combination of all 3 levels of Rally. A mentor will be available to help and answer questions

Saturday Agility Only: Runs will begin at 9:30 am. Agility will be a mix of AKC and UKC equipment at the intermediate skill level. Dogs will run by jump height beginning with small to tall. We will run about 5 dogs of each height and then start over with small dogs as needed.

FACILITIES: The building will be open at 8:00 a.m. on Saturday and Sunday. Crating area and seating is available. Clean up equipment will be available at the exercise area.

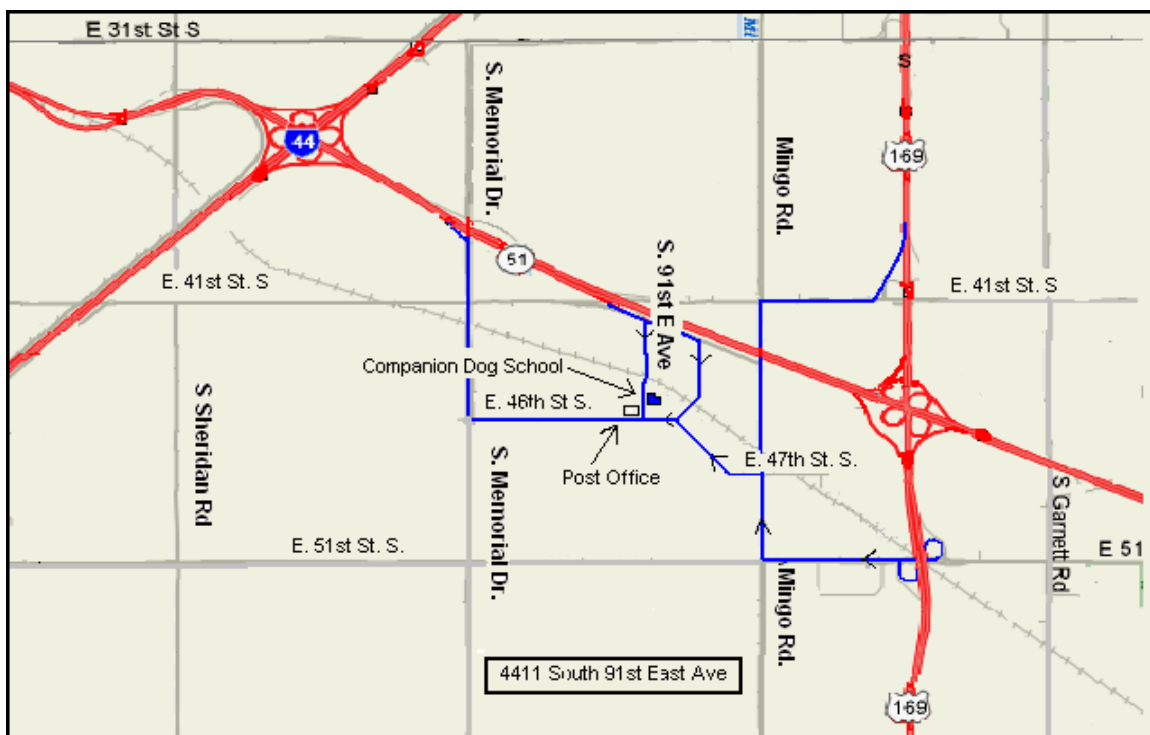
CDST will have coffee, water and soft drinks available as well as light snacks for a nominal cost each day.

They will tell the mentor which class rules they want to practice for pattern calling). The same protocol applies to exhibitors in Rings # 2 and # 3. We are trying this different approach so hopefully you won't have to spend a lot of time waiting for one class to finish before you can show in the next one.
